CORRESPONDENCE: Legislative Updates "Congress Passes COVID Relief Package, Extends CARES Act Deadline This week, Congress came to an agreement and passed another COVID-relief bill. The \$900 billion COVID relief bill does not include direct additional funds for state and local governments. However, the measure does extend the use of CARES Act Coronavirus Relief Funds (CRF) from December 30, 2020 to December 31, 2021, giving townships an extra year to use their funds. The President is expecting to sign the bill this week ahead of the expiration of current federal unemployment benefits on December 26th. The state is likely to adjust related deadlines to line up with federal changes, but those actions have not been taken yet.
