Subject: Township Road Program

Dear Trustees:

The Marion County Engineer's Department is preparing for the summer road work season. Our department is in the process of determining road work needs and are planning to bid the asphalt and seal coat programs in May.

If your township has any interest in joining the County's# 422 Seal Coat Program (Chip and Seal) we will need to know which roads, (name, section, length, and width) or (exact starting and ending points), you are planning. While preparing your estimates you can utilize approximately \$16,000.00 per centerline mile of road as guidance. If this amount is exceeded, we will notify you. We will not be performing any cemetery roads within our contract. Please complete the appropriate sheet and return by Friday, April 15, 2022. We cannot add after this date.

If you are not interested in joining this program we will still be performing estimates and will mail the estimates out within five (5) business days of receiving them. To receive your estimate please complete and return the enclosed, appropriate form to our office as soon as possible. Please include a Township Resolution requesting work in either case.
