Trustee Wolf dialog \$20,770 divided by twelve, then divided by two, said amount \$865.42 is half of fiscal officer monthly pay for 2024, others verify; and Trustee Wolf dialog read aloud the following RESOLUTION # 2024-0205:02 Date February 5, 2024 IN THE MATTER OF APPOINTING A TOWNSHIP ADMINISTRATOR WHEREAS, it was moved by Trustee Trihaft and seconded by Trustee Holcomb to appoint a Township Administrator to serve in a part-time capacity as set forth herein; and WHEREAS, Section 505.031 of the Ohio Revised Code authorizes a board of township trustees to appoint a Township Administrator as administrative head of the township under the direction and supervision of the Board and who shall hold office at the pleasure of the Board; and WHEREAS, the Board of Trustees of Bowling Green Township desires to appoint a Township Administrator to review the policies and procedures of the township and who shall be authorized to receive training necessary to perform administrative and fiscal duties; and WHEREAS, Kristin Columber is Bowling Green Township resident and qualified to serve as Township Administrator; and WHEREAS, upon consideration it is the desire of the Board to appoint Ms. Columber to serve in a part-time capacity as Township Administrator commencing forthwith, and to be paid \$865.42 monthly salary for a maximum twenty (20) hours per week; then THEREFORE BE IT RESOLVED, the Board of Trustees hereby appoints Kristin Columber to the position of Township Administrator to perform the duties identified herein and to serve in this capacity until March 31, 2024, unless otherwise determined by the Board.
